Having completed the Rotumba School project in 2012 with successful outcomes, EFH embarked on a new endeavor at Rogbomtama in the Port Loko District of Sierra Leone. The Rogbomtama 6 block school project costs \$35,000.00 to be incurred over 3 phases in the following manner: a. Phase 1 - site clearing, excavation, and foundation - \$8,000.00. b. Phase 2 - substructure, brickwork, beams, and roofing - \$20,000.00. c. Phase 3 - finishing, floors, walls, ceiling, chalkboard, doors, shelves, etc. - \$7,000.00. In 2013 EFH started Phase 1 with an expenditure of \$4,576.95 . In 2014 Phase 1 was completed at a cost of \$5,200.00.
